5.	One recent biometric passport sized photograph (35x45mm, white background, 70% - 80% face coverage); Head coverings are only accepted for religious reasons. (Do not glue or staple the picture to the application form	
6.	Proof of admission to the relevant University or Institution (scholarship certificate if applicable) (Zulassungsbescheid)	
7.	For English-speaking programs unless you have completed a Bachelor Degree in Australia, UK or US: Proof of knowledge of English language (TOEFL, IELTS)	
8.	For German-speaking programs: Proof of knowledge of the German language ("Zertifikat B1" with a 'good' result or higher is recommended)	
9.	Higher Secondary Education Board Certificate and mark-sheets	
10.	Proof of previous studies in the relevant area (e.g. Bachelor Degree, transcripts)	
11.	Letter of motivation (Please answer the following questions)

 NOTE: Special rules might apply for some nationals which passports are not recognized by the German authorities. You might be requested to come personally to the Embassy. Visa processing will take more time.

II. Information for the applicant on Terms and Conditions of the visa process:

Missing documents may be handed in after the application has been filed with the Embassy. They are to be sent by e-mail, mail or handed in in person at the Embassy's gate. The passport number of the applicant must be indicated on the envelope.

Failure to produce any of the documents above or further documents required within a set period of time is likely to lead to refusal of the application.

All photocopies must be fully legible and will be refused in case they are not.
